

# **Gynecology & Fertility Summit (GFS) - Terms & Conditions**

**Last Updated: 12 November 2025**

These Terms & Conditions (“Terms”) govern your use of the Gynecology & Fertility Summit (“GFS”) website (<https://gfs-conf.com>), digital services, registration platforms, and participation in the conference. Please read them carefully before using the website or registering for the event.

---

## **1. Conference Organizers**

The GFS Conference is jointly organized by:

### **1.1 Aspire Impact Solutions (AIS)**

A Saudi-based company providing event management, marketing, and operational support for GFS.

### **1.2 King's College Hospital - Jeddah (KCHJ)**

A licensed healthcare institution providing scientific, clinical, and academic oversight for the conference.

Collectively referred to as “**the Organizers**”.

## **2. Acceptance of Terms**

By accessing the website, registering, or attending the GFS Conference (in person or virtually), you agree to comply with these Terms and all applicable laws in the Kingdom of Saudi Arabia. If you do not agree, you must discontinue use of the website and refrain from registering for the conference.

## **3. Eligibility**

### **3.1 Attendees**

The conference is intended for:

- Healthcare professionals (Gynecologists, Family Medicine, Women's Health Practitioners, Embryologists, Nurses, and licensed Midwives)
- Researchers and academic professionals
- Residents, interns, medical students (where permitted)
- Industry representatives

### **3.2 Age Requirement**

You must be at least 18 years old to register and use the website. If you are under the age of 18, please consult a parent or guardian before use

## **4. Registration & Payments**

### **4.1 Registration**

Registration is conducted via the official website or approved partners. The Organizers reserve the right to approve or reject registrations.

### **4.2 Payment**

Payments must be made using the available payment methods. Your registration is not confirmed until payment is successfully processed.

### **4.3 Cancellations & Refunds**

- Cancellation requests must be submitted in writing.
- Refunds depend on the cancellation date and subject to administrative fees.
- No refunds will be granted for cancellation requests received within 21 days of the event date.
- The Organizers reserve the right to cancel, reschedule, or modify the event format.

If the event is cancelled by the Organizers, refunds will be issued in full.

If you have extenuating circumstances that prevent you from attending, you are welcome to petition for an exception to this policy. To do so, please submit your cancellation request in writing along with an explanation regarding your situation and include any documentation to support your case (documentation is optional but recommended). These petitions must be submitted within 7 days of the event to be considered. The decision regarding your petition may take up to one month after the event; and subject to approval of the organizers. Petitions with no explanations will not be reviewed.

## **5. Intellectual Property**

### **5.1 Conference Content**

All presentations, slides, recordings, abstracts, documents, and educational materials are the intellectual property of their respective authors or the Organizers.

### **5.2 Permitted Use**

Attendees may not:

- Copy, reproduce, or distribute conference materials
- Record sessions without explicit authorization
- Use scientific content for commercial purposes

## **6. Photography, Videography & Media Usage**

### **6.1 Event Coverage**

The Organizers may capture photos, audio, and video recordings during the conference for documentation and promotional purposes.

### **6.2 Consent**

By attending the event, you grant the Organizers the right to use your image and likeness in conference-related media without compensation. If you object to being photographed or recorded, please notify the Organizers in writing prior to the event.

### **7.1 Speakers**

Speakers are responsible for:

- Adhering to ethical and regulatory guidelines

### **7.2 Exhibitors & Sponsors**

All promotional activities must comply with Saudi laws, scientific integrity standards, and the Organizers' policies.

Attendees must maintain professional behavior at all times. Harassment, discrimination, disruptive conduct, or misuse of conference platforms will result in removal without refund.

Attendees must follow all safety and regulatory instructions at the venue, including, not limited to, infection control, ID verification, and facility protocols. The Organizers may deny entry to individuals who fail to comply.
